# Call Before You Build- for Lakeshore Protection

If you own land within 1,000 feet of Pine or Big Pine Lake you will be subject to shoreland zoning requirements. Though the term "zoning requirements," can induce headaches and/or comas for most people, zoning is an important tool to keep our lakes healthy and neighborhoods valuable in these treasured environments. The best advice we can give shoreland property owners is to call your permitting authority before constructing a building, doing significant dirt work, installing rip rap, clearing brush and trees for a lake view, changing the use of property (ie. turning your residential home into a business), or constructing any impervious surface such as a deck, patio, sidewalk, driveway, or stairway. Some of these activities may not require a permit but will still be subject to a few design guidelines to help protect the integrity of the lake.

The biggest change we have made this year in Pine County is that we now require a permit for driveways and parking areas, as well as patios placed within the required building setback for the given lake. For example on Big Pine Lake you would need a permit to construct a patio within 100' of the lake. The reason this requirement was added is because we also have a requirement that lots may not exceed 25% lot coverage with impervious surface. By requiring permits for driveways, parking areas, and patios we will be able to keep a closer monitor on property development so that lots do not exceed 25% lot coverage with impervious surface, which helps reduce surface runoff and improves water quality.

The Pine Lake area is unique as it is right on the county border. Pine County Planning and Zoning is the permitting authority for lake property owners within Pine County and we can be reached at 320-216-4220. Aitkin County Environmental Services is the permitting authority for lake property owners in Aitkin County and they can be reached at 218-927-7342.

## **Invasive Species**

Boaters need to know invasive species laws

Minnesota boaters and nonresident anglers renewing their licenses will now need to sign a card affirming they know the state's aquatic invasive species laws.

Watercraft owners and nonresident anglers must read and sign the affirmation during their regular license renewal, then keep it with them, along with their license. The affirmation demonstrates understanding that Minnesota law requires license holders to:

- \* Clean aquatic plants and prohibited invasive species from watercraft.
- \* Drain lake or river water from all equipment and keep drain plugs out during transport.
- \* Dispose of unwanted bait in the trash, not in the water.

"No one needs to renew their license earlier than usual, and there is no additional cost or training involved," said April Rust, DNR invasive species coordinator. "This is a simple way of making sure more people using our lakes and rivers know how to follow the laws designed to protect them."

"The affirmation is another positive step in the state's proactive efforts to keep 95 percent of Minnesota lakes off the infested waters list," said Heidi Wolf DNR invasive species unit supervisor. "This season, the state also implemented mandatory training for anyone convicted of violating invasive species laws. Minnesotans are serious about preventing the spread of aquatic invasive species and the recreational, environmental and economic harm they cause."

#### Telephone Tower Update Jeff Lindgren

GOOD NEWS: As many of you have probably noticed, Verizon has begun service on the new cell tower at the northwest corner of Big Pine Lake on the north side of Highway 18. The service began Thursday, July 14. This is great news for all Verizon customers but not so much for people with other service plans. I called the owner of the tower recently to find out if there are any plans to add AT&T, T-Mobile or other service providers. He indicated they have received no requests from any of the other carriers but that people could call their provider and tell them a tower was just built in our area with service from Verizon.

On another note I recently had a call from a supervisor at Frontier Communications. Frontier provides internet access to many people on our lakes through the phone lines and as you may know, service is not that great for a LOT of people. He said that the Finlayson area will receive upgrades to its infrastructure in our area beginning next year, that the vast majority of customers will have a minimum of 5 Mbps download speeds and that faster speeds will be available.
